Barbara McQuiston, Special Assistant for Energy, DARPA

GLENDALE, CA - Los Angeles County Tech Week 2009 announced today that the keynote speaker is Barbara McQuiston, Special Assistant for Energy, Defense Advanced Research Projects Agency (DARPA), and previous Los Angeles County entrepreneur. During her tenure at DARPA, Ms. McQuiston has directed over \$1 billion in high tech development funding for the federal government. She has more than 25 years of experience in both research and development as well as management of high-technology companies and government programs.

As a Los Angeles entrepreneur, she was President of McQuiston and Associates, a management consulting firm working with technology start-up companies. By supporting many global technology and management institutions, McQuiston was successful in accelerating the growth of QWIP Technologies, Inc., a Jet Propulsion Lab spinout and high growth company. QWIP was also an early tenant of The Los Angeles County Business Technology Center (BTC), one of the largest high technology incubators in the country.

“To have one of our own BTC alumna come back “on campus” as the keynote speaker at our eleventh anniversary celebration and L.A. County Tech Week event, is truly coming full circle for the BTC, and fulfilling our mission of fueling entrepreneurship,” said Stan Tomsic, the Administrator of the BTC.
